Bidders may submit requests for consideration of a proposed Substitution for a specified product, equipment, or service to the Architect no later than ten (10) days prior to the bid opening (provide a copy to the Construction Manager of all requests submitted). Additional products, equipment, and services may be accepted as approved Substitutions only by written Addendum.
