Project Overview

A. Project Description

This project includes the following:

1. Design and construction of one (1) new Elementary School and one (1) new High School. The location of the new elementary is planned to be built within a residential subdivision on property the District owns. The High School is planned to be built near the site of the existing High School. As a separate project the District will be renovating the existing High School as a Locally Funded Initiative concurrently with construction of the new High School; selection of a design professional for this separate project will be conducted independently by the District.
2. Abatement and Demolition of the existing Oregon and Searfoss elementary school buildings and Willis C. Adams Middle School shall be included as part of the scope of work.
3. The District plans to vacate the existing elementary schools in June of 2016. Swing space work is not included in this scope of work.
4. Development of all phases of design including the Program of Requirements (POR)
5. The new PK-5 elementary and 9-12 high schools are required to achieve LEED Silver Certification at a minimum.
6. The anticipated project delivery method for this project is Construction Manager at Risk.
7. Prevailing Wage requirements do not apply to this project

B. Scope of Services

For projects advertised with an appropriately developed Program of Requirements (POR), upon award of the Agreement, commence with Design. For projects without such a POR, upon award of the Agreement, commence by developing the Program of Requirements.

The selected Architect/Engineer (A/E), as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner and/or the Contracting Authority, the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute and the Agreement.

As required by the Agreement, and as properly authorized, provide the following categories of services: Program Verification, Schematic Design, Design Development, Construction Document Preparation, Bid and Award Support, Conformed Documents, Construction Administration, Post-Construction, and Additional Services of all types. Refer to the Ohio School Design Manual for additional information about the type and extent of services required for each. Request for Qualifications (Architect / Engineer) continued

During the construction period, provide not less than 16 hours (excluding travel time) on-site construction administration services each week, including (1) attendance at progress meetings, (2) a written field report of each site visit, (3) on-site representation comprised of the A/E and its consultant staff involved in the primary design of the project, all having relevant and appropriate types of construction administration experience.

For purposes of completing the Relevant Project Experience Matrix in Section F of the Statement of Qualifications (Form F110-330), below is a list of relevant scope of work requirements for this RFQ:

1. Design and administration of PK-12 construction in a residential area and also on an occupied High School site
2. Projects that utilize the Construction Manager at Risk project delivery method
3. Accurately estimating construction cost through design
4. Using the Ohio School Design Manual for PK-12 facility design, 2014 version
5. Working on projects with school districts and OFCC.
6. Developing contract documents for building demolition and abatement
7. OSDM projects that achieve or exceed LEED Silver certification with the goal of reaching Silver certification 12 months after Owner occupancy.
8. Knowledge of CM cost estimating, scheduling techniques, and multiple GMPs.
9. Knowledge of the OSDM project budget and the ability to translate it to new CMR delivery model and cost tracking.
10. Able to develop a working relationship with the selected CMR firm that fosters cooperation throughout the design and construction phases. It is the Owner's desire to successfully conclude GMP negotiations no later than 50% through CD phase of each school project at or below budget.
11. Experience with OAKS.

- Experience and capabilities of creating or using Critical Path Method (CPM) schedules and of using CPM schedules as a project management resource.
- Approach to and success of using partnering and Alternative Dispute Resolution.
- Proximity of prospective firms to the project site.
- Proposer's apparent resources and capacity to meet the needs of this project.
- The selected A/E and all its consultants must have the capability to use the Internet within their normal business location(s) during normal business hours.

Interested A/E firms are required to submit the Commitment to Participate in the EDGE Business Assistance Program form in its Statement of Qualifications (Form F110-330) submitted in response to the RFQ, to indicate its intent to contract with and use EDGE-certified Business Enterprise(s), as a part of the A/E's team. The Intent to Contract and to Perform and / or waiver request letter and Demonstration of Good Faith Effort form(s) with complete documentation must be attached to the A/E's Technical Proposal. Both forms can be accessed via the OFCC website at <http://ofcc.ohio.gov>. The Intent to Contract and to Perform form is again required at the Fee Proposal stage.

Use the "print" feature of Adobe Acrobat Professional or similar software for creating a PDF rather than using a scanner. If possible, please reduce the file size of the PDF. In Adobe Acrobat Professional, go to Advanced, then PDF Optimizer. Also, please label the CD and the CD cover with the project number and firm name.

Facsimile or e-mailed copies of the Statement of Qualifications will not be accepted.

Firms are requested to identify professional registrations, memberships and credentials including but not limited to: LEED GA, LEED AP, LEED AP+, CCCA, CCM, CCS, CDT, DBIA, CPE, and any other appropriate design and construction industry credentials.
