Project Overview

A. Project Description

The Ohio State University is seeking an architectural firm to submit qualification for a renovation in the 18th Avenue Library, located on the Columbus campus. Approximately, 9,700 sq ft of the third floor will become a Research Commons.

The Research Commons will become the main point of connection between researchers and the variety of services and resources supporting research at The Ohio State University. Services provided within the third floor space will facilitate the key steps of the research process; create a focus for conversation, relationship-building, and a greater sense of participation in, and understanding of, the full spectrum of research. The Research Commons will serve to provide a collaborative environment for researchers to interact and connect, spontaneously or scheduled; multi-function spaces for presentations and group sessions; and showcase displays, that infuse current OSU Research into the Research Commons environment.

Technology will play a critical role in the completed project. Displays and interactive functions used for presenting data visualizations will be incorporated into the design for immediate implementation, as well as, future expansion.

The project scope includes all new finishes, as well as, renovations to electrical wiring, mechanical systems, and networking as required by the design. The restrooms and existing staff office space are excluded from the project scope.

The other floors and staff area of the third floor will remain occupied throughout construction.

The Architect (A/E) will prepare a Program of Requirements.

B. Scope of Services

The A/E is expected to demonstrate dynamic leadership and successful experiences in higher education library projects. The ability to incorporate audio visual technology into a multifaceted facility, without making it the focal point, will be highly rated. The A/E must have experience collaborating with multiple user groups coexisting in a common finished space. Experience working with Construction Managers at Risk and familiarity with Guaranteed Maximum Price negotiations is strongly desired.

Sophisticated programming and high quality design is required to deliver a library environment for research support services that is not only unique to the Ohio State University, but from any other library. The environment created is to be distinguished from other areas of campus, draw researchers in, and allow for exposure to and interaction with multidisciplinary fields of research. Relevant technology incorporation is to enhance research investigation and communication organically.

Upon award of the Agreement, commence the development of the Program of Requirements. This will be a collaborative process that builds on an existing study and the incorporation of the following needs:

- A colloquia space for seminar sessions

- A secure computer work area for specialized software and equipment
- Private consultation space
- A data visualization space
- Group study areas
- Administrative office
- Storage
- Video conference space
- Smaller presentation space
- Distinguishing entrance into third floor Research Commons

The A/E will be required to prepare cost estimates through the Design Development phase and participate in the estimate reconciliation process with the CMR.

Design Documents for the GMP submittal will be 65%-75% complete. The exact percentage will be determined, by the University, at a later date.

The selected Architect/Engineer (A/E), as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner/Contracting Authority, the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute and the Agreement. Required Professional Liability Insurance will be per Exhibit A – A/E Terms and Conditions Article 7.2.6.

As required by the Agreement, and as properly authorized, provide the following categories of services: Program of Requirements, Schematic Design, Design Development, Construction Document Preparation, Bid and Award Support, Conformed Documents, Construction Administration, Post-Construction, and Additional Services of all types.

The selected A/E will be required to sign the standard agreement. No modifications to the requirements in the agreement will be accepted.

During the construction period, provide not less than **6** hours (excluding travel time) on-site construction administration services each week, including (1) attendance at progress meetings, (2) a written field report of each site visit, (3) on-site representation comprised of the A/E and its consultant staff involved in the primary design of the project, all having relevant and appropriate types of construction administration experience.

For purposes of completing the Relevant Project Experience Matrix in Section F of the Statement of Qualifications (Form F110-330), below is a list of relevant scope of work requirements for this RFQ:
