Project Overview

A. Project Description

The purpose of this project is to renovate two existing steeply sloped lecture style halls (Hughes Hall 141/161). The floor will be demolished and a new structural slab that decreases the slope in the lecture hall to 8% will be built. New classrooms will be created beneath the slab. Included in the project scope is replacement of all fixed seating, acoustical ceiling systems and wall panels, floor coverings, AV systems and other finishes. New demonstration counters and sinks will be added at the teaching wall. MEPF work includes fire proofing, fire suppression, fire alarm, plumbing, HVAC and electrical/technology.

Construction must start May 16, 2016 immediately after Graduation Commencement 2016. Construction must be substantially completed by Dec. 2, 2016 with total A/E completion anticipated by February 2017.

B. Scope of Services

The selected A/E, as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner and/or the Contracting Authority, the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute and the Agreement.

As required by the Agreement, and as properly authorized, provide the following categories of services: Program Verification, Schematic Design, Design Development, Construction Document Preparation, Bid and Award Support, Conformed Documents, Construction Administration, Post-Construction, and Additional Services of all types.

Refer to the *Ohio Facilities Construction Manual* for additional information about the type and extent of services required for each. A copy of the standard Agreement can be obtained at the OFCC website at <http://ofcc.ohio.gov>.

During the construction period, provide not less than 8 hours (excluding travel time) on-site construction administration services each week, including (1) attendance at progress meetings, (2) a written field report of each site visit, (3) on-site representation comprised of the A/E and its consultant staff involved in the primary design of the project, all having relevant and appropriate types of construction administration experience.

A keen understanding of the requirements for contractor work schedules in cooperating with the university staff/student environment will be a key factor in performing administration services for this project. Previous experience in OFCC forms and documents work, higher education, an occupied facility with a high concentration of staff and students and lecture hall/classroom space experience.

In Acrobat, go to Advanced, then PDF Optimizer. Also, please label the CD or DVD and the sleeve with the project number and firm name if applicable.

Paper copies of the Statement of Qualifications, if requested, should be stapled only. Do not use special bindings or coverings of any type. Cover letters and transmittals are not necessary.

Facsimile copies of the Statement of Qualifications will not be accepted.

Firms are requested to identify professional registrations, memberships and credentials including: LEED GA, LEED AP, LEED AP+, CCCA, CCM, CCS, CDT, CPE, DBIA, and any other appropriate design and construction industry credentials. Identify that information on the resume page for individual in Block 22, Section E of the F110-330 form.
