### Project Overview

#### A. Project Description

The Ohio Bureau of Workers' Compensation (BWC) currently occupies two locations in the greater Cleveland area: private-sector leased office space in Garfield Heights and Level 6 in the state-owned Lausche Building. This phased project will renovate all of Lausche Level 6 and approximately half of Level 7 so that BWC can relocate staff from Garfield Heights and consolidate operations within the existing Lausche office building. Level 6 encompasses 30,526 Usable Square Feet (USF), and the work area on Level 7 is 17,205 USF. The combined total usable square footage for this project is 47,731.

All aspects of the project and related issues will be implemented and operated consistent with the Contracting Authority and Owner's policies and procedures.

#### B. Scope of Services

The renovation will include selective demolition; construction of new interior partitions and limited new hard ceilings; installation of new interior doors and break room casework; interior finishes including flooring, ceilings, and painting; window treatments; reconfiguration of fire suppression and HVAC systems; installation of new HVAC units to serve large meeting spaces; relocation/removal of some existing light fixtures; installation of new electrical devices and some new specialty light fixtures; electrical/data for office furniture systems; network cabling and data devices; and fire alarm work.

For projects advertised with an appropriately developed Program of Requirements (POR), upon award of the Agreement, commence with Design. For projects without such a POR, upon award of the Agreement, commence by developing the Program of Requirements.

The selected A/E, as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner and/or the Contracting Authority, the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute and the Agreement.

As required by the Agreement, and as properly authorized, provide the following categories of services: Program Verification, Schematic Design, Design Development, Construction Document Preparation, Bid and Award Support, Conformed Documents, Construction Administration, Post-Construction, and Additional Services of all types.

During the construction period, provide not less than 4 hours (excluding travel time) on-site construction administration services each week, including (1) attendance at progress meetings, (2) a written field report of each site visit, (3) on-site representation comprised of the A/E and its consultant staff involved in the primary design of the project, all having relevant and appropriate types of construction administration experience.

- Relevant past work of prospective firm's proposed consultants.
- Past performance of prospective firm and its proposed consultants.
- Qualifications and experience of individuals directly involved with the project.
- Proposer's previous experience (numbers of projects, sizes of projects) when working with its proposed consultants.
- Specification writing credentials and experience.
- Experience and capabilities of creating or using Critical Path Method (CPM) schedules and of using CPM schedules as a project management resource.
- Approach to and success of using partnering and Alternative Dispute Resolution.
- Proximity of prospective firms to the project site.
- Proposer's apparent resources and capacity to meet the needs of this project.
- The selected A/E and all its consultants must have the capability to use the Internet within their normal business location(s) during normal business hours.

Identify that information on the resume page for individual in Block 22, Section E of the F110-330 form.
