The Ohio Facilities Construction Commission administers several programs that provide state assistance to school districts in the acquisition, construction, and renovation of classroom facilities. Each of those programs is centered on the development of a Master Facility Plan that addresses the entire facility needs of the school district. The districts listed on this chart are those eligible to participate in Vocational Facilities Assistance Program (CFAP) and the VFAP Expedited Local Partnership Program (VFAP-ELPP). This chart reflects the program of each district through these programs towards completion of all necessary facility work.
