



OAKS CI is a construction management system for State of Ohio-sponsored capital improvement projects, and is available at no cost to school districts, state-funded agencies and institutions of higher education.

OAKS CI USERS

State agencies, school districts, higher education facilities, architects, engineers, construction managers, contractors, project managers, scheduling managers, project coordinators and fiscal staff

OAKS CI BACKGROUND

OAKS CI is a web-based project management system, sponsored by the Ohio Facilities Construction Commission, which makes data readily available, ensures project communication and collaboration, and reduces the potential for litigation. Currently, it provides EDGE (Encouraging Diversity, Growth and Equity) participation reporting for construction projects and construction vendors.

The functional scope of OAKS CI includes:

- Collaborative management involving all of the project team
- Integration from conceptual planning and design through procurement, project execution, and closeout
- Document approval and tracking through workflow based on OFCC processes
- Budget control and cost tracking; dynamic change management functionality that feeds budget management
- Shared document repository reducing printing, handling, and mailing

- Powerful reporting and information query tools

OAKS CI MIGRATES TO CLOUD

OAKS CI migrated to a cloud-based system in February 2015. One benefit of the cloud system was accessibility and device independence.

ELECTRONIC SIGNATURES

OFCC implemented an electronic signature process in early 2016. This update provides a safe and secure way to sign documents quickly through email via your computer or cell phone.

The Process

Instead of printing and signing documents received in OAKS CI, electronic signatures are accessed directly from an email account. This process significantly reduces the time it takes to sign and approve records.

The record that is received electronically will have all associated backup attached, and neither the document nor the backup can be modified. Once the document

The OAKS CI Support Team provides users with a growing bank of job aids and pre-recorded webinar sessions that can be viewed at any time. Registration and passwords are not required.

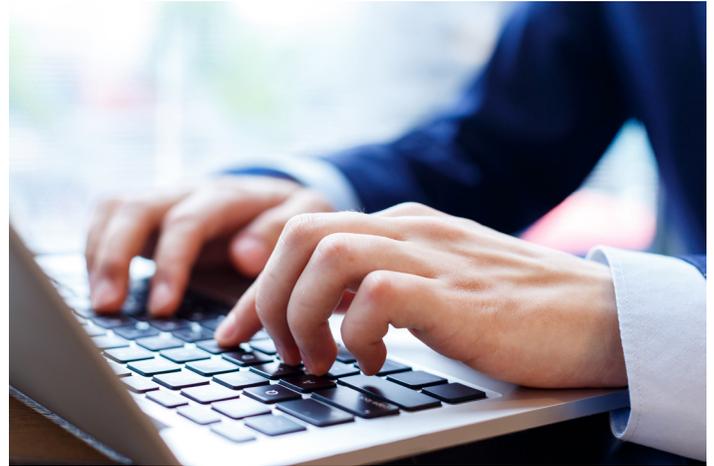
Training and job aid topics are broken down into areas of specific interest for Agency and Higher Education and K-12 project clients.
