Project Overview

A. Project Description

Northwest Ohio Psychiatric Hospital, located at 930 S Detroit Avenue in Toledo, Ohio is a three -story restricted and secure residential psychiatric hospital environment (Occupancy Group I-2; NFPA Health Care Occupancy, Limited Care Facility) that operates on a 24/7, 365-day per year schedule. There are six separate and similar residential patient units; four are located on the 1st floor and two are located on the 2nd floor. The hospital utilizes a Patient Programming Area where patients leave their residential units to attend various programing activities in a centralized location.

This project includes the replacement of the 4 existing 4-steam boiler units with new hot water and domestic water heating boilers. A/E will review existing conditions and evaluate pipe, pumps, valves that would be necessary for this change. Coordinate any possible conflicts with existing mechanicals, pipe, duct, electrical, etc. This project will require phased construction.

B. Scope of Services

For projects advertised with an appropriately developed Program of Requirements (POR), upon award of the Agreement, commence with Design. For projects without such a POR, upon award of the Agreement, commence by developing the Program of Requirements.

The selected A/E, as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner and/or the Contracting Authority, the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute and the Agreement.

As required by the Agreement, and as properly authorized, provide the following categories of services: Program Verification, Schematic Design, Design Development, Construction Document Preparation, Bid and Award Support, Conformed Documents, Construction Administration, Post-Construction, and Additional Services of all types.

- Experience and capabilities of creating or using Critical Path Method (CPM) schedules and of using CPM schedules as a project management resource.

- Proposer's apparent resources and capacity to meet the needs of this project.
- The selected A/E and all its consultants must have the capability to use the Internet within their normal business location(s) during normal business hours.
