Project Overview

A. Project Description

The Alber Student Center was built in 1986 and is the campus crossroads for OSU Marion and Marion Tech student life. The facility functions as the primary location for students to socialize, recreate and engage in wellness activity. The goal of the project is to attract and engage current and potential students by creating a welcoming environment with natural light and student centric spaces.

The renovation includes an approximately 17,000 sq ft reorganization of office, wellness, fitness, student organization gathering, activity spaces and new food service with interior and exterior dining space. Planning is to include locations for primary and secondary building additions with exterior connectivity.

This project is required to be designed and delivered within a collaborative BIM-enabled environment following The Ohio State University BIM Project Delivery Standards. The project will have the minimum requirements and the University will coordinate with the Design team for the primary deliverables. The Primary firm submitting for the project will be required to have the BIM expertise capable of meeting the aforementioned standards. B. Scope of Services

For projects advertised with an appropriately developed Program of Requirements (POR), upon award of the Agreement, commence with Design.

The selected A/E, as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner and/or the Contracting Authority, the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute and the Agreement. Required Professional Liability Insurance will be per Exhibit A – A/E Terms and Conditions Article 7.2.6.

As required by the Agreement, and as properly authorized, provide the following categories of services: Program Verification, Schematic Design, Design Development, Construction Document Preparation, Bid and Award Support, Conformed Documents, Construction Administration, Post-Construction, and Additional Services of all types.

The selected A/E will be required to sign the standard agreement. No modifications to the requirements in the agreement will be accepted.

During the construction period, provide not less than 6 hours (excluding travel time) on-site construction administration services each week, including (1) attendance at progress meetings, (2) a written field report of each site visit, (3) on-site

representation comprised of the A/E and its consultant staff involved in the primary design of the project, all having relevant and appropriate types of construction administration experience.

Closeout Services: The closeout for this project is required to be delivered in an electronic cloud-based format adhering to The Ohio State University Project Closeout Standards. The Ohio State University Project Closeout Standards can be accessed via the OSU FOD vender resource website (<https://fod.osu.edu/resources>) under Post Construction / Close Out.
